**PROJECT OVERVIEW**

**1. INTRODUCTION**

The City is soliciting for the services of a licensed Contractor who could provide Dog Waste Removal Services.

**2. BACKGROUND**

The City's Dog Parks (listed below) require that scheduled, reliable Dog Waste Removal Services should be provided. The City may require that additional locations also be services.

**3. SCOPE OF WORK**

The Contractor shall be responsible for the replenishment of plastic dog waste bags for the Mutt Mitt ® stations, and plastic liners for the collection cans for the following Dog Park locations at:

The Contractor shall supply all labor, materials, equipment, and supervision necessary for providing this service.

Services shall be provided two (2) times each week on Tuesdays and Fridays. Services shall also be provided after sunrise and completed before 10:00 a.m. The City may require that additional locations also be serviced.

**INSTRUCTIONS TO BIDDERS**

**1. STATEMENT OF CONFIDENTIALITY**

It is understood and agreed that all information pertinent to this solicitation may contain trade secrets, which are confidential and proprietary. The selected bidder agrees not to disclose or knowingly use any confidential or proprietary information of the City and/or third-party participant.

Bid submissions are subject to the Maryland Public Information Act (Education Article, Maryland Annotated Code, §10-611, et seq.). In accordance with the Act, certain information is subject to public disclosure. Please be advised that should you deem any portion of your bid as confidential or proprietary, it must be conspicuously indicated on those portions so deemed. **2. TERM OF AGREEMENT**

The initial term of this contract is anticipated to begin July 1, 2025, and last through June 30, 2026.

**9. DURATION OF QUOTATION**

A bid submitted in response to this solicitation is binding upon the bidder and is considered irrevocable for a minimum of 60 days following the closing date for receipt of initial bids.

**10. BASIS OF AWARD**

Contract(s) shall be awarded to the qualified, lowest responsible and responsive bidder(s) offering the lowest bid price on the total lump sum for one (1) year contract term.

Pricing shall remain firm for the initial term of the agreement.

**11. OPTION TO RENEW CONTRACT PERIOD**

- A. Upon satisfactory service and by mutual agreement the City reserves the right to renew the contract. The term of renewal shall not exceed two (2) additional one (1) year periods.
- B. The City expects all bidders to provide year over year cost reductions recommendations.
- C. Price decreases are acceptable at any time, need not be verifiable, and are required should the contractor/producer/processor/manufacture experience a decrease in costs associated with the execution of the contract.
- D. Price adjustments from the contractor/producer/processor/manufacture for any/all items may be considered at renewal. The request is subject to approval by the Director of Procurement. The request must be submitted in writing at least sixty (90) days prior to the renewal term and shall be accompanied by supporting documentation. The increased contract unit price shall not apply to orders received by the Contactor prior to the effective date of the approved

increased contract unit price. The City may cancel, without liability to either party, any portion of the contract affected by the requested increase and any materials, supplies or services undelivered at the time of such cancellation. The request for a change in the unit price shall include as a minimum; (1) the cause for the adjustment; (2) proposed effective date (minimum of 90 days); and, (3) the amount of the change requested with documentation to support the requested adjustment (i.e. appropriate Bureau of Labor Statistics, Consumer Price Index (CPI-U) change in manufacturer's price, etc.).

E. Should the awarded bidder, at any time during the life of the contract, sell materials of similar quality to another customer, or advertise special discounts or sales, at a price below those quoted within the contract, the lowest discounted prices shall be offered to the City.

## 12. REFERENCES

Bidder is to provide at least three (3) references **(City's Reference Form, Attachment A)** and submit with the quote. The references must be for work performed within the past three years and for whom the bidder has provided similar goods/services of similar size and scope as determined by the City of Rockville.

## 13. INSURANCE REQUIREMENTS

The successful contractor shall meet all of the insurance requirements contained within this document. The contractor shall be required to furnish a certificate of insurance to include endorsements for additional insured and waiver of subrogation.

Prior to execution of the contract by the City, the Contractor must obtain at their own cost and expense and keep in force and effect during the term of the contract including all extensions, the following insurance with an insurance company/companies licensed to do business in the State of Maryland evidenced by a certificate of insurance and/or copies of the insurance policies. The Contractor's insurance shall be primary.

The Contractor must submit to the Procurement Division, 111 Maryland Ave, Rockville, MD. 20850 a certificate of insurance prior to the start of any work. In no event may the insurance coverage be less than shown below.

Unless otherwise described in this contract the successful contractor and subcontractors will be required to maintain for the life of the contract and to furnish the City evidence of insurance as follows:

**A. Policy Cancellation**

No change, cancellation or non-renewal shall be made in any insurance coverage without thirty (30) days written notice to the City's Procurement Division. The Contractor shall furnish a new certificate prior to any change or cancellation date. The failure of the Contractor to deliver a new and valid certificate will result in suspension of all payments and cessation of on-site work activities until a new certificate is furnished.

**B. Additional Insured**

The Mayor and Council of Rockville, which includes its elected and appointed officials, officers, consultants, agents and employees must be named as an additional insured on the Contractor's Commercial and Excess/Umbrella Insurance for liability arising out of contractor's products, goods, and services provided under the contract. Additionally, the Mayor and Council of Rockville must be named as additional insured on the Contractor's Automobile and General Liability Policies. Endorsements reflecting the Mayor and Council of Rockville as an additional insured are required to be submitted with the insurance certificate.

**C. Subcontractors**

All subcontractors shall meet the requirements of this section before commencing work. In addition, the Contractor shall include all subcontractors as insured under its policies or shall furnish separate certificates and endorsements for each subcontractor. All coverages for subcontractors shall be subject to all of the requirements stated herein.

**14. TERMS AND CONDITIONS**

Any contract entered in connection with this solicitation shall be subject to the General Terms and Conditions of this solicitation except as otherwise modified herein.



It shall be the Contractor's sole responsibility to insure they are compliant with all applicable federal, state, and county laws, rules, ordinances, statutes, etc., that may impact this contract. The City shall bear no responsibility for monitoring the Contractor's compliance with said legal requirements. If the Contractor fails to maintain legal compliance, The City may find said Contractor in default.

**15. ENVIRONMENTAL IMPACT**

It is the intent of the City of Rockville to increase opportunities for minority, female and disabled (MFD) owned businesses to compete effectively at supplying goods, equipment, and services to the City, within the constraints of statutory purchasing requirements, departmental needs, availability, and sound economic considerations. Suggested changes and MFD enhancements to this document's requirements for possible consideration and/or inclusion in future like requirements are encouraged.

**16. COOPERATIVE PROCUREMENT**

The Contractor may extend all of the terms, conditions, specifications, and unit or other prices of any award resulting from this solicitation to any and all other public bodies, subdivisions, school districts, community colleges, colleges, and universities. The City assumes no authority, liability or obligation, on behalf of any other public entity that may use any contract resulting from this solicitation.

**PART III**  
**TECHNICAL SPECIFICATIONS**

**1. CONTRACTOR RESPONSIBILITIES**

The tasks listed below shall be performed each time the dog park is serviced:

- A. Contractor shall remove dog waste filled trash liners from the collection cans and remove any trash/debris in the collection can.
- B. Contractor shall reline collection cans with a new plastic liner. Liners shall be provided by the Contractor and fit the collection can appropriately so as not to tear or separate during regular use.
- C. Contractor shall refill the Mutt Mitt stations with pet waste dispenser bags that are Mutt Mitt ® brand or equivalent in size and quality. Pricing options will determine party responsible for providing the bags. See price pages 6 - 7.
- D. Each Mutt Mitt station shall be filled to maximum capacity allowed for each station.
- E. All waste shall be taken off site by Contractor and disposed of properly.
- F. Contractor's materials, equipment, and practice shall conform in strength, quality of material, appearance, and workmanship that is usually and reasonably provided by the Contractor's trade.

**2. CONTRACTOR'S EMPLOYEES**

Contractor's employees must be in uniform and display a neat and clean appearance at all times. All employees must be pleasant and courteous to the public and City staff during all work. Contractor is required to have a staff member who is fluent in English present at all times.

Contractor must establish a written safety and health policy and provide training materials in a language and at a literacy level that all employees can understand. In addition, the Contractor will assess each job for safety hazards and design a work plan that addresses methods dealing with the hazards while performing dog waste removal services.

All employees of the Contractor shall be no less than 18 years of age and shall be experienced in the type of service work being performed.

**3. SUBCONTRACTING**

There shall be **NO** subcontracting or assignment of work delegation.

**5. WORK SCHEDULE**

Services shall be performed two (2) times each week on Tuesdays and Fridays and shall take place after sunrise and shall be completed before 10:00 a.m.

**6. MUTT MITT ® EQUIPMENT**

The current Mutt Mitt ® stations are Model #02401 (green). These stations shall be refilled with the Mutt Mitt's ® pet waste dispenser bags Model #02450 or equivalent size and quality.

**7. DOG WASTE DISPOSAL**

Contractor shall properly dispose of dog waste and comply with all Federal, State, County, and local regulations with regards to dog waste disposal.

**8. SPECIAL RESPONSE**

If a situation arises where dog waste services are required immediately, the Contract Administrator will contact the Contractor and the Contractor shall respond within a four (4) hour period. Contractor shall provide a telephone number and/or email for use outside normal business hours if such a need arises.

**9. ADDITIONAL LOCATIONS/SERVICES**

The City reserves the right to add locations/services or delete locations/services specified in the resulting contract as requirements change during the contract period. In the event additional locations require service, the Contractor shall supply a written estimate, based upon the pricing submitted with this request for quote, to the Contract Administrator within three (3) days after request. Once approved, the purchase order will be modified adding the new location(s) and authorizing the Contractor to proceed.

**10. CONTRACTOR REQUIREMENTS**

- A. Contractor shall be of established reputation with a minimum of five (5) consecutive years' experience and regularly engaged in the performance of the specified work. Contractor's date of incorporation/organization must be more than 5 years before the date of release of this Bid Document.
- B. Contractor shall be a licensed contractor in the State of Maryland and shall comply with all state and local codes.
- C. Contractor shall immediately notify the Contract Administrator, via phone call or text message, if an unavoidable delay is expected or encountered.
- D. Contractor shall be responsible for damage to the City of Rockville's, the general public's, or any other third-party service provider's equipment and/or property by its work, negligence in work, and/or it's equipment.

- E. Contractor shall be responsible and liable for the safety, injury, and health of their employees while performing the service.
- F. All employees of the Contractor shall be no less than 18 years of age and shall be experienced in the type of the work performed. No visitors, spouses, or children of the Contractor's employees will be allowed while the area is being serviced, unless they are employees of the Contractor.
- G. The City of Rockville is committed to maintaining an alcohol and drug free workplace. Possession use or being under the influence of alcohol or controlled substances by Contractor's employees while in the performance of this service is prohibited. Violation of this requirement shall constitute grounds for termination of this contract. In addition, Contractor's employees shall observe the City of Rockville's and Montgomery County, Maryland no smoking policies.
- H. It is the intent of the City of Rockville to purchase goods, equipment, and services having the least adverse environmental impact, within the constraints of statutory purchasing requirements, departmental needs, availability, and sound economic considerations. Suggested changes and environmental enhancements for possible inclusion in future revisions of this specification are encouraged.
- I. The services provided under these specifications shall be performed using the latest methods and practices in current use by the industry.
- J. All equipment, items and services not specifically mentioned which are necessary for this service to be performed, or which are normally furnished, as standard, shall be provided by the Contractor. All equipment, items and services shall conform and be used in accordance to the accepted standard of the industry.
- K. Contractor shall perform this contract as an independent contractor and shall not be considered an agent of the City of Rockville, nor shall any employees or agents of the Contractor be considered an agent of the City.

#### **11. SAFETY AND CLEANLINESS**

- A. Contractor shall provide for a neat, clean, and safe environment during all work, as determined by the City of Rockville. All vehicles, trailers, and other equipment must be in proper working order and in a neat, clean appearance, as determined by the City of Rockville.
- B. Employees of the Contractor shall be of neat appearance and conduct themselves in a professional manner while working for the City of Rockville, as determined by the City of Rockville.
- C. Contractor shall provide to the Contract Administrator, after award, a current written list of employees who will be servicing the City's dog park.

- D. Contractor shall leave the location site clean, safe, and free of any tools and other materials related to the work.
- E. Contractor shall be responsible for ensuring the safety of both their employees and the City's employees while performing dog waste removal services. Proper safety signs or cones shall be used while performing any service.

## **12. TRANSIT TIME**

All cost associated with travel related expenses (e.g.: meals, mileage, lodging, per diem, etc.) are the responsibility of the Contractor and shall be factored into the price of the quote.

1. **TERMS AND CONDITIONS** The terms and conditions of this document govern in event of conflict with any terms of the bidder's proposal, and are not subject to change by reasons of written or verbal statement by the contractor unless accepted in writing. Words and abbreviations which have well known technical or trade meanings are used in accordance with such meanings.
2. **SUBMISSION OF QUOTE** All quotes are to be submitted to the location indicated on the front page of the Request for Quotation form. Unless otherwise specified, the following forms must be submitted:
  - Bid Form
  - Affidavit (form attached)
  - W-9
  - References, if requested
  - Other forms as requested in the document.

The form must be typed or written in ink. Conditional bids and bids containing escalator clauses will not be accepted. All bids must be regular in every respect and no interlineation, exclusions, or special conditions shall be made or included. Bids must contain an original signature, in the space provided, of an individual authorized to bind the bidder.

3. **LATE BIDS** It is the bidder's responsibility to assure delivery of the bid at the proper time to the designated location. Bids delivered to any other office or location will not be considered.
4. **ADDENDUM** In the event that any addendum to this solicitation is issued, all solicitation terms and conditions will remain in effect unless they are specifically changed in the addendum. 24. **CHANGES IN QUANTITIES/ITEMS** The City reserves the right to add or delete any item(s) from the bid in whole or in part at the City's discretion as given in the Bid or Proposal wherever it deems it advisable or necessary so to do and such changes shall in no way invalidate the contract nor affect the bid prices for any item or remaining work. Unit prices submitted in the bid shall not be increased or decreased regardless of changes in quantity. The City may waive minor differences in specifications in bids provided these differences do not violate the specifications' intent nor materially affect the operation for which the items or services are being purchased.
- The Contractor will be paid for the actual amount of authorized work done or material furnished under any item of the bid at the price bid and stipulated for such item. If the Contractor fails to comply with nondiscrimination clauses of this contract or fails to include such contract provisions in all subcontracts that subcontractors will not discriminate against any employee or applicant for employment in the manner described above, this contract may be declared void AB INITO, cancelled, terminated or suspended in whole or in part and the Contractor may be declared ineligible for further contracts with the City of Rockville. Any employee, applicant for employment, or prospective employee with information concerning any breach of these requirements may communicate such information to the City Manager who shall commence a prompt investigation of the alleged violation. Pursuant to such investigation, the Contractor will permit access to the Contractor's books, records, and accounts. If the City Manager concludes that the Contractor has failed to comply with nondiscrimination clauses, the remedies set out above may be invoked.

38. **PERMITS AND REGULATIONS** Unless stipulated elsewhere in these specifications, the Contractor shall be responsible for obtaining and paying for all applicable permits.
39. **PATENT RIGHTS** Whenever any article, materials, equipment, process, composition, means, or things called for by these specifications is covered by letters of patent, the successful bidder must secure, before using or employing such article, material etc., the assent in writing of the Owner or Licensee of such Letters of Patent and file the same with the City.

The said assent is to cover not only the use, employment, and incorporation of said article, material, equipment, process, composition, combination, means, or thing in the construction and completion of the work but also the permanent use of said article, material, etc., thereafter by or on behalf of the City, in the operation and maintenance of the project for the purposes for which it is intended or adapted. The Contractor shall be responsible for any claims made against the City, its agents and employees or any actual or alleged infringement of patents by the use of any such patented articles, etc., in the construction and completion of the work, and shall save harmless and indemnify the City, its agents and employees from all costs, expenses, and damages, including Solicitor's and Attorney's fees which the City may be obligated to pay by reason of any actual or alleged infringement of patents used in the construction and completion of the work herein specified.

40. **SUBLETTING OR ASSIGNING OF CONTRACT** The City and the Contractor each bind themselves, their partners, successors, assigns and legal representatives of such other parties in respect to all covenants, agreements, and obligations contained in the contract documents. Neither party to the contract shall sublet, sell, transfer, assign or otherwise dispose of the contract or any portion thereof, or of the work provided for therein, or of his right, title or interest therein to any person, firm or corporation without

the written consent of the other party, nor shall the Contractor assign any monies due or to become due hereunder without the previous written consent of the City.

41. **SUBCONTRACTING** When allowed, bidders who intend to subcontract any portion of the work including delivery, installation or maintenance will submit to the City prior to the start of work: 1) a description of the items to be subcontracted, 2) all subcontractor names, addresses and telephone numbers and 3) the nature and extent of the work utilized during the life of the contract. This does not relieve the contractor from the prime responsibility of full and complete performance under the contract. There shall be no contractual relationship between the City and any subcontractor.
42. **NO WAIVER OF CONTRACT** Neither the acceptance by the City nor any order, measurement, certificate or payment of money, of the whole or any part of the work, nor any extension of time nor possession taken by the City shall operate as a waiver of any portion of the contract, or any right to damage therein provided. The failure of the City to strictly enforce any provision of this contract shall not be a waiver of any subsequent breach of the same or different nature.
43. **GUARANTEE PERIOD** The Contractor shall warrant and guarantee the work required under this contract for a period of twelve (12) months from the date of Final Acceptance. The Contractor warrants and guarantees to the City, that materials and equipment furnished under the contract shall be of good quality and new unless otherwise required or permitted by the contract documents, that all work will be in accordance with the contract documents, and that all work will be of good quality, free from faults and defects. Work not conforming to these requirements, including substitutions not properly approved and authorized, may be considered defective. If required by the City, the Contractor shall furnish satisfactory evidence as to the kind and quality of materials and equipment. The Contractor's obligation to perform and complete the work in a workmanlike manner, free from faults and defects and in accordance with the contract documents shall be absolute. The Contractor shall remedy, at his own expense, and without additional cost to the City, all defects arising from either workmanship or materials, as determined by the City, or City's representative. The obligations of the Contractor under this Paragraph shall not include normal wear and tear under normal usage.  
  
If the Contractor does not, within ten (10) days after notification from the City, signify his intention in writing or inaction to correct work, as described above, then the City may proceed with the work and charge the cost thereof to the account of the contract as herein before provided. Warranty documents shall be furnished by the Contractor and shall be delivered to the City before final payment is made.
44. **NOTICE TO BIDDERS** Companies not incorporated in the State of Maryland must be in compliance with the State of Maryland Code of Regulations Title 21, State Procurement Regulations in order to enter into a contract with the City. "Pursuant to 7-201 et seq. of the Corporations and Associations, Article of the Annotated Code of Maryland corporations not incorporated in the State, shall be registered with the Department of Assessments and Taxation, 301 West Preston Street, Baltimore, Maryland 21201 before doing any interstate or foreign business in this state. Before doing any intrastate business in this state, a foreign corporation shall qualify with the Department of Assessments and Taxation." Bidders must supply with their bids their US Treasury Department Employer's Identification Number as such number is shown on their Employer's Quarterly Federal Tax Return (US Treasury Department Form No. 941). 45. **QUALIFICATION TO CONTRACT WITH PUBLIC BODY** Bidders must be qualified to bid in the State in accordance with Section 16-202 of the State Finance and Procurement Article of the Annotated Code of Maryland which ordains that any person convicted of bribery in furtherance of obtaining a contract from the state or any subdivision of the State of Maryland shall be disqualified from entering into a contract with the City
